

General Guidelines for Poster Submission

Posters will be evaluated by the Scientific Committee to determine their suitability for the congress. Submissions must clearly fall within the scope of Environmental Health. In other words, any work on health topics that is not properly contextualized within this field will not be accepted.

Examples of valid topics include studies, research, or case reports related to **pest/harmful organism management, Legionella management, or indoor air quality**. Contributions may address any of the three thematic areas: spaces, water, and air.

Posters must present relevant contributions to the congress theme in a clear and visual way, and will be displayed on panels in the congress venue.

Requirements

- Posters must be submitted to the dedicated email: **posterexpocida@anecpla.com**. Submissions sent by any other method will not be accepted. The deadline for submission is **December 31, 2025**.
- Posters may be submitted in **Spanish or English**, but not a mix of both in the same poster.
- Each registered participant may submit up to **2 posters**, which must be completely different.
- Posters must be submitted by the **main author**, who must be clearly identified in the work presented.

Poster Submission Details

The following information must be included:

- **Thematic Area** – Authors must indicate which of the three thematic areas applies:
 - **Pest management in spaces:** topics may include pest prevention, monitoring, treatments, case studies in urban ecosystems, links with emerging or re-emerging diseases, strategies for controlling native or invasive species, waste management, use of biocides, and environmental health strategies to protect public health, etc.
 - **Pest management in water:** topics may include treatment methods, products, protocols, success stories, environmental impacts of treatments, studies on Legionella, sustainable use of biocides, water management, etc.
 - **Pest management in air:** topics may include advances in duct disinfection treatments, indoor air pollution data, case studies on indoor air quality management, and related health data, etc.

- **Title of the communication** – Written in **uppercase and bold**, without underlining. Scientific species names must be formatted correctly.
- **Main author** – Full profile including name, surname(s), and contact details (affiliation, mailing address, and email).
- **Co-authors** – Full names and contact details (affiliation and mailing address, if different from the main author).
- **Keywords** – Three keywords must be identified.

Format: Posters must be submitted in **.ppt or .pptx** format (PowerPoint, Google Slides, Keynote, etc.), with a maximum file size of **100 Mb**, to facilitate review.

Printing: Posters must not be printed until official written approval is received from the Scientific Committee.

Size: Posters must be in **A0 format (84 x 118 cm), vertical orientation**.

Design: No specific style requirements. Authors may design freely.

Material: Printing on paper or lightweight material is recommended, to prevent posters from falling due to weight and to ensure proper adhesion with tape.

Display: Posters will be exhibited during both days of the congress. Authors are responsible for the installation and removal of their posters. Once accepted, the Scientific Committee will provide details regarding the day, time, and schedule for setup, removal, and presentation.

Important

Only posters that strictly follow these submission instructions will be accepted for review.

Notification of Acceptance and Scheduling

All posters will be reviewed for quality and relevance by the Scientific Committee. The main author will receive notification of acceptance or rejection by email, along with details about scheduling.

⚠ Important: Once the evaluation result is received, the main author or at least one co-author must complete registration for the congress no later than **February 5, 2026**.

By submitting their work, authors grant the congress organizers permission to display it in all congress materials, as well as to make it available in PDF format for download by congress participants after the event.
